
As recommended by the J&K Services Selection Board, Jammu, sanction is hereby accorded to the appointment of Mr. Aman Sharma S/o Mr Hari Krishan Sharma R/o Kallar, Udhampur as Warper-cum-Winder in PB-I 5200-20200+ Grade Pay Rs 1900 (PR) in Handloom Development Department (District Cadre), Udhampur, subject to the condition that:

- a) The appointee shall report to the office of the Joint Director Handloom at Udyog Bhawan, Rail Head Complex, Jammu, within a period of 21 days from the date of issuance of this order.
- b) In case the appointee fails to join within stipulated period of 21 days, his appointment shall be cancelled without any further notice.
- c) The appointee shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarters by the Joint Director Handloom, Jammu:-
 1. Academic/Technical Qualification Certificates.
 2. Date of Birth Certificate/Matriculate certificate.
 3. Health Certificate, issued by the Competent Authority/CMO.
 4. Permanent Resident Certificate issued by Competent authority.
 5. Relevant Category Certificate (in case the candidate belongs to Reserved Category).
 6. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

The appointment of the above said candidate as Warper-cum-Winder shall further be subject to the following conditions:-

- a. If on verification, the certificate(s) produced by the appointee is/are proved fake or forged, the appointment shall be cancelled ab-initio.
- b. The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that in case any adverse report about his character and antecedents is received from the Inspector General of Police, CID, Jammu and Kashmir to whom a reference shall be made by the Department, his appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.

- c. The salary of the appointees shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.
- d. In terms of SRO 202, the appointee shall be entitled to the minimum scale of pay alongwith the grade pay applicable to the post against which he is appointed. The appointee shall be on probation for a period of five years.
