Whereas the Administrative Department vide letter No. IND/HL/20/2016 dated 22.3.2017, forwarded the recommendation of Ms Riffat Nazli D/o Shri Jawaid Iqbal R/o Kilhotral Balessa, Doda for the post of Assistant Tailor Master, Handloom Development Department, Divisional Cadre Jammu (RBA Category) in pursuance to the advertisement notification 03 of 2012 dated 28.12.2012 (Item No. 191) issued by the J&K Services Selection Board, Jammu under letter No. SSB/Secy/Sel/ 2017/ 2266-72 dated 22.2.2017; and

Whereas Ms Riffat Nazli D/o Shri Jawaid Iqbal R/o Kilhotral Balessa, Doda was also selected by J&K SSB as Tailor Master under Division Cadre Jammu against Item No. 158 (02 of 2014) dated 30.12.2014 under OMI/RBA Category, has been appointed as Tailor Master vide Order No DHD/07 of 2017 dated 6.4.2017 and has joined in the Handloom Development Department, and

Whereas Smt Samreena Banoo D/o Shri Ab Majeed W/o Tariq Hussain R/o Kilhotral Balessa, Doda who stands in the waiting list at S.No.1 whereby Smt Riffat Nazli has been selected as Assistant Tailor Master, has represented the Director Handloom for her appointment as Assistant Tailor Master, and

Whereas, the Administrative Department was requested by the Directorate vide letter No.DHD/Est/3341/1111 dated 19.9.2017 to convey approval of the competent authority to operate the waiting list in question; and

Whereas the Administrative Department vide letter No. IND/HL/20/2016 dated 29.6.2018, besides furnishing the J&K Services Selection Board letter No. SSB/Sel/Secy/2018/1069-71 dated 23.01.2018 wherein release of withheld recommendation in favour of Smt Samreena Banoo figuring at S No 1/RBA/Wait under Item No. 191 has been released, has requested this Directorate to operate the waiting list of Assistant Tailor Master under RBA Category against the item No. 191 (3 of 2012) for the appointment of Ms. Samreena Bano D/o Abdul Majeed W/o Tariq Hussain R/o Kilhotral Balessa, Doda

Now, therefore, Smt Samreena Bano D/o Abdul Majeed W/o Tariq Hussain R/o Kilhotral Balessa, Doda is hereby appointed as Assistant Tailor Master in PB-1 Rs 5200-20200+ Grade Pay Rs 2400 (PR) in Handloom Development Department (Divisional Cadre), Jammu.

The appointee shall report to the office of the Joint Director Handloom at Udyog Bhawan Rail Head Complex, Jammu within a period of 21 days from the date of issuance of this order. The appointee shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarters by the Joint Director Handloom, Jammu

1. Academic/Technical Qualification Certificates
2. Date of Birth Certificate
3. Health Certificate, issued by the Competent Authority.
4. Permanent Resident Certificate
5. Relevant Category Certificate.-
6. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

The appointment shall be subject to the following conditions:-

- a. If on verification, the certificates produced by the appointee is proved fake or forged, the appointment shall be cancelled ab-initio.
- b. The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that in case any adverse report about his character and antecedents is received from the Inspector General of Police, CID, Jammu and Kashmir to whom a reference shall be made by the Department, her appointment shall deemed to be cancelled ab-initio and she shall have no claim on her appointment.

The salary of the appointees shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.

The appointee shall be on probation for a period of two years.

In case the appointee fails to join within stipulated period of 21 days, her appointment shall be cancelled without any further notice.
